Window highlights include ROTO NT hardware, locally sourced IG units, double or triple panes, a low-e coating and argon fill.
- North American style casement windows These windows are also manufactured from uPVC profiles (REHAU's 1400 Series). Window highlights include ROTO stainless steel casement hardware, PFG glass (PFG Glass Industries Ltd, a Supplier in Langley, BC.), dual or triple panes, low-e coating and argon fill.

Door Types Offered

• Various types, including in-swing, out-swing French doors, tilt and turn doors and tilt and glide doors. All of these doors are based on the RENAU Brilliant Design vinyl profiles and feature ROTO hardware.

Curtain Wall System

The Company is a licensed fabricator for the REHAU Polytec 50 curtain wall system. This system is a
unique, high performance system that can be used both as a full-fledged curtain wall for use in highrise buildings or as a window wall system. The system consists of a structural steel core, with
external aluminum pressure plates and cover caps, completely isolated from the steel structure, and
internal vinyl caps. The curtain wall system is a new addition and to REHAU and EuroLine is the only
fabricator that has completed product orders thus far.
